SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a non-reservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

NOTE.—Age limits, fourteen to twenty years. Preferably fourteen to eighteen. Students must be at least one-fourth Indian, preferably full Indian. Special cases beyond the age limit will be given consideration. An industrial course only can be taken and the term reduced to three years, in exceptional cases.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations, or Indian schools, to nonreservation schools.

My dear Mr. Welch:

When your favor of the 11th instant was received here this morning it was at once referred to our school physician with a request that he advise whether there is any possible chance of sending your son Jesse home. Before your letter was received by the physician he had made a report as follows regarding Jesse's condition and it was sent to me with a statement to the effect that there is no chance at all at this time of sending him to your home.

"I regret to acquaint you with the serious condition of Jesse Welch. For the past five days he has retained practically nothing on his stomach, whereas rectal feeding too has been entirely unsatisfactory. Please acquaint his people with the fact that Jesse's condition has assumed serious proportions."

Regretting very much that so unfavorable a report has to be conveyed to you and that Jesse's decline has been so rapid as to make his leaving for your home inadvisable and now impossible, I remain,

My dear Mr. Henderson:

Immediately upon receipt of your telegram of this morning to the effect that James and Jesse Welch are needed at their home on account of the serious illness of two other members of their family the matter was taken into consideration with the young men. James decided he would prefer not to go home at this time and because he is twenty-three years of age I believe it advisable to respect his wishes in the matter. Jesse is anxious to go home but stated that he can not get ready to go before tomorrow afternoon. Arrangements are being completed to have him leave then and transportation to Ela will be provided for his use. A sufficient amount of his funds has already been placed on deposit with which to pay for his ticket home and with which a ticket can be provided for his use when he is ready to return to Carlisle.
