SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a nonreservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

NOTE.—Age limits, fourteen to twenty years. Preferably fourteen to eighteen. Students must be at least one-fourth Indian, preferably full Indian. Special cases beyond the age limit will be given consideration. An industrial course only can be taken and the term reduced to three years, in exceptional cases.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that-

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations, or Indian schools, to nonreservation schools.

Dear Mr. Lipps:-

Mrs. Dimmick is in receipt of your letter of October eighteenth and also the letter you received from Elizabeth Francis. At Mrs. Dimmick's request, I am replying to same.

We think that this girl has in her the making of a very good pupil and worker but she has a natural instinct which retards her very much at the present time and that is a disinclination to work which is sometimes called by another name.

As to her hours, she does notget down stairs until between 6:20 and 6:30 in the morning as I am personally up at six 0'clock and nearly always have to wait for her for my breakfast at 6:45.

Now as to her work, in the morning she prepares my breakfast and her own, part of which is generally done the night before, clears up the kitchen and washes the few dishes, straightens up her own room and makes her bed. She sometimes dusts the down stairs furniture and sweeps the porches. You will certainly realize that this is very little work for the morning before eight o'clock. Mrs. Dimmick has a woman one or two days a week for the heavier work.

My daughter attends toher own breakfast and Mrs. Dimmick attends to our boy's and her own. Elizabeth has no reason for this work to be finished up down stairs any later than eight o'clock and ifshe does not finish until five or ten minutes later Mrs. Dimmick sends her upstairs to fix up her own room and get ready for school. She requires from fifteen to twenty minutes easy walking to reach the school from our house.

I certainly donot see that this is any hard work or any excuse for being late and we were not aware of any lateness with one exception.

In the evening after she reaches home from school, she assists with the dinner which is served at 6:15 to 6:30 and nearly always finished by seven o'clock. It happens but very rarely that 1 am detained a half hour later which of course will probably require fifteen minutes more to finish up. All her work is to clear

up the dining room and wash the dishes, after which she is at liberty to study for the rest of the evening. There is no excuse whatever for her to be any later than eight o'clock and she is nearly always through before that time.

I have personally asked her about school and about her lessons but she always answered me "I have none". This seemed very strange and 1 asked Mrs. Dimmick to call at the school to see why she had no home work when 1 knew that our children always had work of that kind. Since then and for the last few days she has had home work and my daughter has assisted her in solving her problems.

We are, of course, only too glad to give her all the assistance to improve her standing in school but is is a difficult matter with her.

As to her health, I cannot speak authoratively as to her sight but Mrs. Dimmick will call on the school Doctor during the coming week, as she is personally acquainted with him, and ascertain the trouble and what his advice is in the matter, which we will be pleased to communicate to you as soon as we have something definite.

I might addthat Mrs. Dimmick insists on whatever work Elizabeth does must be done correctly and she has had considerable trouble in that direction, as she has a spirit to decline to do so when asked to do over which she has not done properly, and it is only by strenuous insistence that she will do it. She resents this force but think this will be alright as we try to treat her very pleasantly andtry to get her to reciprocate.

We trust that Miss Johnson will call at an early date and personally corroborate this statement.


