The reservation superintendent should send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

If the information called for on any part of the blank is not known, that fact should be stated. No space should be left unfilled. Whether the parents are living or dead, their names must be given.

The person who signs the blank as consenting to the transfer should indicate his relation to the applicant by marking out the word "parent," "guardian," or "next of kin," leaving unmarked only the title appropriate to the signer.

The enrollment of Indian pupils in nonreservation schools is governed by the "Rules for the Indian Service, 1913," sections 12, 13, 14, 15, 18, 19, 36, 112, 113, 114, 117, 118, 124 (b).

The Rules should be consulted before filling out the application blanks.

Dear Mr. Francis:

Referring to your letter of April 23 relative to a request received from the guardian of Mary Johnson that she be permitted to come home for the summer vacation, this matter was referred to the Field Clerk at Atoka and I have a reply from him as follows:

"Replying to your letter of April 26, 1918, in re Mary Johnson, a Chickasaw Indian minor, you are advised that I have talked to Islin Wright, her guardian, and he says that he would like for her to spend a part of her vacation at his home at Atoka, Oklahoma. I might state that Mr. Wright's wife is a sister of Mary Johnson. Mr. Wright states that his ward has about \$1000.00 to her credit and since she has ample funds and has not been at home for three years, I believe it would be advisable that she return home for part of a vacation".

In view of the Field Clerk's statements I recommend that Mary be permitted to come home for the vacation provided the necessary deposit is made by her guardian for paying her expenses home and in returning to the school at the beginning of next term.

My dear Sir:

This is to acknowledge receipt of your letter of the 9th instant and to inform you that students at this school are provided with all necessary articles of clothing from the supply that is furnished by the Government. However, a number of the young people enrolled at Carlisle have money of their own that is allowed them from time to time to purchase extra articles of clothing that cannot be provided by the Government. There is no objection to students using what money they can spare to purchase clothing, but you must know best whether Mary Johnson can afford the expenses she desires to incur.

You are advised further that a charge of twenty-five cents for each lesson is now made here for music lessons. A deposit of an amount of \$5.00 should be ample for your ward's immediate use for that purpose.

My dear Sir:

Upon receipt of your letter of recent date in which you expressed the desire that arrangements be made so that Mary Johnson can begin the study of piano music the matter was taken into consideration with our school matron and our teacher of music. Just at present a place in the class cannot be found for her and it is believed that it will be advisable not to take up the work at all until the opening of the next school year. That will give Mary the opportunity to gain knowledge in other lines of work and the privilege to begin taking the lessons at the beginning of the year.

Noting in your letter that Mary does not have any funds to pay for wearing apparel while she is in school, I take this opportunity to inform you that everything she needs to be comfortable is provided by the government and that any extra money she might have could be used only to

provide such articles of clothing as are not furnished by the government and not absolutely essential to a girl's comfort and well-being while at Carlisle.

Dear Mr. Francis:

Sometime ago Mary Johnson, a student in your school, wrote me that she wanted to come home during the summer and visit her parents. Since receiving Miss Johnson's letter, I wrote to the probate attorney in whose district her guardianship case is pending, to ascertain whether she had sufficient funds in the hands of her guardian, Mr. J. S. Wright, of Ada, to pay her transportation to Oklahoma and return to school. I am advised that in the annual report filed by this guardian in January, 1917, there was shown a balance of \$559.87 due this ward, and in view of the fact that the guardian has no material objections to his ward returning to Oklahoma, it is agreeable with this office that she be allowed to return, if, in your opinion, you think it advisable. Her coming, however, is conditioned upon her returning to Carlisle in time for the opening of the fall term.

VACATION REQUEST FOR PUPIL.

We, the undersigned, respectfully request that leave of absence be granted

..... Mary Johnson

from June, 1918 to to

enable her to visit home. We hereby agree to pay all expenses, including round-trip railroad fares, sleeping-car fares, meals, lodging, stage fares, telegraph and telephone messages, and other incidental expenses connected with the visit. We further agree that said pupil shall be returned to the Carlisle Indian ... school on or before the last day of the leave of absence. We further agree to deposit with the superintendent of the school sufficient money to defray all expenses to be incurred, and should the pupils, or any one of them, fail to return to school at such time as may be agreed upon by the parents or guardian and the superintendent of the school in which the pupils are enrolled, the amount of money remaining with the superintendent, necessary to the return transportation of the pupil or pupils so neglecting to return, shall be forfeited to the Government; provided, however, that in all cases where it can be shown that there were justifiable reasons for the failure of the return of the pupil the forfeiture of the funds shall not take place.

If the pupil neglecting to return is from a reservation, the superintendent of the reservation shall certify to the reasons for the nonreturn of the pupil or pupils. If a pupil's home is not on a reservation, then the certificate of some reputable, disinterested citizen of the community may be requested as to the reasons for the nonreturn of the pupil or pupils.
