INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations, or Indian schools, to nonreservation schools.

I am sending you the Five by check. marked good.

I arrived in Phila. all right and had little trouble in getting a room. I have been going to the Y. W. C. A. for my meals until this morning for I did not get up until rather late, so I breakfasted on some fruit that I bought yesterday.

This being Sunday I simply don't know how to amuse myself, being alone for the first time.

I start to work on Monday, lucky that I am just one block from
my apartment

My dear Mrs Demney;

This is Christmas again, I have been fortunate lately by meeting Mr. Paul Baldeagle, a person whom I have always wanted to meet as he seems to be interested in about the same things, especially in education.

My work is growing more pleasant every day as I become better acquainted with affairs about this place. However I was shifted about

the first few days, but now my hours are from seven to three in the afternoon. Looks as if I will have to go to night school.

Yesterday as soon as I left the Office building I went to Collingswood to see my dear friends, Mr. & Mrs. Berry, whom I first lived with in the summer of 1913., I hadn't intended to stay over night but Mrs. Berry insisted that I stay until Mr. came home. It certainly was a surprise to them.

On my way to supper this evening I met Mr. Christman

but since his train was there I didn't have much time to say anything to him. Thus my blues are fast fading away.

Today is payday but since I haven't been there a week I will have to wait until next week. This is the reason I am writing to you because I have not enough to pay for my room and board for the following week. On my arrival I paid for my room as we are requested to do at the beginning of the week.

Now I wanted to know if
 you would kindly lend me
 about five dollars and I will,
 as soon as I get my pay
 next week, send back your money.

No doubt Kankakee is now
 a very exciting place and yet
 at the same time a sad place.
 However I am glad you people
 are going to remain, so we
 homeless Indians here in the
 City will feel that we still
 have very dear friends near us.
 With every sincere wish for

Dear Mr. Francis: -

On Saturday I visited Christine Metzger in regard to the Atlantic City proposition. Christine has made inquiries and had at hand the enclosed information. Will you look it over and let me know your opinion.

I would suggest that we allow Christine to go to the Chalfonte for the following reasons: - She is restless - tired of cooking and house work - not settled in her plans for food - does not want anything I have to offer her in the way of a shore home. She is a graduate of high school and has an excellent record - entirely reliable in character - and surely should now be able to care for herself. I told her I could appreciate the fact that she was tired of housework since she has stuck closely to it for five years going through to school.

Mrs. Chrusman favors letting Christine go to the Chalfonte. She says Christine is slow but competition there with the other waitresses may be the very best thing for Christine. Christine is willing that a part of her wages should be sent to the school for banking the same as heretofore. If you think it advisable I could go to Atlantic City and have an interview with the manager of the Leeds B. Christine can remain with Mrs. Chrusman until she makes a change. My dear Mrs. Henney;

I had the pleasure of meeting a member of your tribe this morning a Mr. Queroad, he gave a very interesting talk to the students of the High School today, and I am sure that everyone enjoyed it very much.

My lessons of late have been much longer than usual, nearly everyone requires reference work in the library, the only spare time I have now is at noons just after lunch which is about thirty minutes

Next month on the twentieth the Juniors and Seniors are to write their Dowling Prize Essays, we are given five weeks to prepare for this essay and each class has its own subject, our subject is about the territorial expansion of the United States dating back to the purchase of the Louisiana territory to the late purchase of the Spanish West Indies, the senior subject is on preparedness. To write this essay we have from nine o'clock to twelve, it first must be written on tablet paper then copied all in one morning, we are to have not less than twelve hundred words and not more than twenty-four hundred, all I have to say is that, there is no danger of me getting beyond twenty-four hundred, I doubt whether I can make twelve hundred, nevertheless I will try, there are two prizes one for each class.

On the ninth of this month we Juniors gave a reception in honor of the Senior class, this affair was given in the New Century club house, every Junior member was present but sorry that all the Seniors were not able to come.
