COMPULSORY SCHOOL LAW.

School Code Passed and Approved 1911.—Article XIV.

Sec. 1414. Every child having a legal residence in this Commonwealth as herein provided between the ages of eight and sixteen years is required to attend a day school in which the common English branches provided for in this Act are taught; and every parent guardian or other person in this Commonwealth having control or charge of any child or children between the ages of eight and sixteen years is required to send such child or children to a day school in which the common English branches are taught; and such child or children shall attend such school continuously through the entire term during which the public elementary schools in their respective districts shall be in session. * * The board of school directors in any district of the fourth class may at a meeting held at any time before the opening of the school term reduce the period of compulsory attendance to not less than seventy per centum of the school term as fixed in such district in which case however the board of school directors must at the same time fix the period for the compulsory attendance to begin.

Sec. 1416. The provisions of this Act requiring regular attendance shall not apply to any child between the ages of fourteen and sixteen years who can read and write intelligently and is regularly engaged in any useful and lawful employment or service during the time the public schools are in session and who holds an employment certificate issued according to law.

Sec. 1423. Every parent, guardian or person in parental relation in this Commonwealth having control or charge of any child or children between the ages of eight and sixteen years who shall fail to comply with the provisions of this Act regarding compulsory attendance shall be guilty of a misdemeanor, and on conviction thereof before any alderman, magistrate or justice of the peace shall be sentenced to pay a fine for the benefit of the school district in which such offending person resides not exceeding two dollars (\$2.00) for the first offense, and not exceeding five dollars (\$5.00) for each succeeding offence together with costs and in default of the payment of such fine and costs by the person so offending shall be sentenced to the county jail for a period not exceeding five days, x x x Provided that before any proceedings are instituted against any parent, guardian or person in parental relation for failure to comply with the provisions of this Act such offending person shall have three days' written notice given him by the superintendent of public schools, supervising principal, attendance officer or secretary of the board of school directors of such violation; and if after such notice has been given the provisions of this Act regarding compulsory attendance are again violated by the persons so notified at any time during the term of compulsory attendance such person so again offending shall be liable under the provisions of this Act without further notice.

To Parents or Guardians.

In giving excuses for the absence of pupils from school, the cause of absence must be fully stated and must be an "urgent reason". Your hearty co-operation is requested as the provisions of the Law are clearly stated and must be observed by all.

I have your letter dated April 12th, making inquiry relative to your son Claudie Morgan. Claudie came to me early this spring and made a special request to go under the Outing this coming summer and to remain out next winter. I instructed the Outing Agent to get him a good home where he could remain through the winter and attend school. This has been done and Claudie is now living with

Mr. T. H. Ford,
Trenton, N. J.,
RFD # 3.

A letter addressed to him, in care of this gentleman will reach him.

I also see that you wish him to take up some kind of a trade. While the records show that Claudie is sixteen years of age, he is very much under size and I do not think it advisable to put him in the shop where heavy work is to be done. Perhaps living on a farm this summer will help him grow so that in another year he may be able to take up a trade. This can be determined after he returns to school.

While I wish, as much as possible, to consider the desires of the parents, regarding their children, I think it best, while they are in our school, that the matter of what is best for the child should be left to the Superintendent and the employees, who understand the rules and the conditions of the school better than the parents. Claudie has been used to much freedom in Montana and I believe it is best for his health that he have a change from school life to farm life. This is one of the reasons why he was sent under the outing.

I hope you will understand that I am trying to do what seems to be the best for your little boy.
