SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a non-reservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

NOTE.—Age limits, fourteen to twenty years. Preferably fourteen to eighteen. Students must be at least one-fourth Indian, preferably full Indian. Special cases beyond the age limit will be given consideration. An industrial course only can be taken and the term reduced to three years, in exceptional cases.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations, or Indian schools, to nonreservation schools.

Sir;

I have the honor to report that Nora Buffalo, a student of this school, was operated upon for Appendicitis at the Hospital this morning and is in a very critical condition.

Nora Buffalo was taken ill Sunday night but was not deemed to be seriously ill by the Physician until late yesterday when symptoms developed which made the Doctor feel that an early operation was essential to save the life of the girl.

The parents of Nora are dead. She has two sisters enrolled at the school. Superintendent Deaver of the Quapaw Agency from which she is enrolled has been advised of her condition and requested to advise her relatives or guardian.

My dear Mr. Quapaw:

I today wired you as follows:

"It became necessary to operate upon Nora Buffalo for acute appendicitis this morning. She is in critical condition. Will keep you advised."

Nora was taken ill Sunday night. The school physician saw her on Monday and on Tuesday she was removed to the Hospital but it was not considered that her case was serious until Tuesday night when symptoms developed which caused the school physician to feel that an operation would probably be necessary. Another physician was called from town in consultation and it was determined to operate this morning.

This was done. While the school physician has not yet made his formal report to me, I am advised that when the appendix was removed it was found that part of it had sloughed away and that infection was present. As far as I can learn the conditions led the physician to believe that there was a chronic condition which had suddenly become acute. I am advised that Nora has, at different times in the past, had some pain in her side.

The presence of infection makes the recovery of Nora very problematical. However, despite the discouraging news from the Hospital, we are hoping that Nora will recover. We just had a report from the Hospital to the effect that her temperature was normal, her pulse pretty good and that things were looking more hopeful.

My dear Mr. Deaver:

Last night I advised you by wire that Nora Buffalo had an apparent case of Appendicitis and that it was necessary to operate if the diagnosis was confirmed and asked you to assure her parents that they would be kept fully advised.

I wired you this morning:

"Notify relatives or guardian, of Nora Buffalo operated on this morning. She is in critical condition."

I likewise telegraphed Benjamin Quapaw, Baxter Springs, Kans:

"It became necessary to operate upon Nora Buffalo for acute Appendicitis this morning. She is in critical condition. Will keep you advised."

Our records show that Benjamin Quapaw signed the enrollment blank for Nora Buffalo, but we do not have the name of her Guardian. I will be glad to have you advise me as to this.

Nora was taken ill Sunday night. The school Physician saw her on Monday and on Tuesday she was removed to the Hospital but it was not considered that her case was serious until Tuesday

night when symptoms developed which caused the school Physician to feel that an operation would probably be necessary. Another Physician was called from town in consultation and it was determined to operate this morning.

This was done. While the school Physician has not yet made his formal report to me, I am advised that when the appendix was removed it was found that part of it had **sloughed away** and that infection was present. As far as I can learn the conditions led the Physician to believe that there was a chronic condition which had suddenly become acute. I am advised that Nora has, at different times in the past, had some pain in her side.

The presence of infection makes the recovery of Nora very problematical. However, despite the discouraging news from the Hospital, we are hoping that Nora will recover,



Dear Sir:-

I wish to report that at 7 A.M. this morning Nora Buffalo, was operated on at the school hospital for what appeared to be Acute Appendicitis and on opening her abdomen a very much inflamed and thickened peritoneum presented itself which when opened liberated a small quantity pus like fluid.

The intestines where also very much inflamed and bound down by adhesions making it very difficult to locate the appendix which was found turned upon itself and tightly adherent to the back. This was carefully loosened and as much removed as was possible with safety, and drainage established.

At present her condition is critical owing to the presence of peritonitis which however we hope to conquer.

It is appazent from the above conditions which were found, that this must of been a chronic case of long standing.

I can give you much more encouraging news than the wire gives by explaining the conditions. It should be understood that Nora is suffering with peritonitis and until the infection is absolutely conquered she will be in serious condition and not out of danger.

At present the infected area is draining well. She has practically no temperature, her pulse is strong, and severe vomiting spells which were present from the beginning have left her. She is also able to take some nourishment. She is quite strong; every day ingresses her chances to get well.

We are very hopeful, but Nora is still a very sick girl and there is a possibility of complications which would bring about a fatal termination.
