He is a boy of splendid character and can do the actual work in a shop himself but I fear he would fall down as an instructor. He is a Pueblo and like many of his tribe, he has a very poor command of English. He is in the fifth grade and has three more years before his term expires. I doubt too the wisdom of sending a warm climate boy up into your cold country, especially at this time of the year. So I think that Charles Brown would better remain here and complete his term. I do not know of any one else whom I could recommend for the place.
