SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a non-reservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

NOTE.—Age limits, fourteen to twenty years. Preferably fourteen to eighteen. Students must be at least one-fourth Indian, preferably full Indian. Special cases beyond the age limit will be given consideration. An industrial course only can be taken and the term reduced to three years, in exceptional cases.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that-

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations, or Indian schools, to nonreservation schools.

Dear Mr. Lipps:

I am in receipt of carbon copy of your letter of the 7th instant to Miss Clara Shunion, one of the Carlisle pupils, home on account of the death of her sister. It is noted that Clara contemplates leaving school and remaining on the reservation to care for the children of the deceased sister, and you speak of forwarding her money to her and cancelling the order for her ticket placed pending her return to school.

I had previously talked to Clara with reference to returning to school and she had agreed to do so without delay. There are three of the children in question, one of which is in school, the other two in the hands of an aunt who is perfectly able to care for the same without assistance from Clara who should complete her education at this time. If you have not already done so I would suggest that you do not send her money to her and that you allow the order for the ticket to stand at the same time counselling her to return to Carlisle

for a few years at least. Her return to the reservation at this time would mean a lapse into tribal customs and would probably render most of the efforts expended in her behalf ineffective.

I should be glad to hear from you in regard to this at your earliest convenience.



You can assure Clara, as I have already done by letter, that she need have no worry whatever. The aunt is receiving payment of ten dollars per month, and at least one of the children is in school. We have authority whereby the money can be paid to meet any emergency which may arrive, and the children are being properly cared for. The money is all on deposit along with an additional sum of \$395.00, to the credit of wach child, so there is no cause for worry in behalf of the children.

Clara should remain until her education is completed, and even then it is advisable that she secure imployment outside the reservation, if possible, for her own good.


