INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations, or Indian schools, to nonreservation schools.

My dear Mr. Wyly:

On Saturday evening, December 22d, Willie Deere of Okema, Okla. and John Davis whose former guardian was R. A. Howard of Ardmore, Okla., deserted from this school. Cards received from them show that they passed through St. Louis enroute to their homes.

I am very desirous of having these boys returned to the school for the following reasons. Both of them have been fairly good students and have had no trouble, John Davis having become a commissioned officer at the beginning of the year while Willie was a sergeant. On November 24, 1917 they attended the Penn-Carlisle game at Philadelphia, and while there they, with two other boys, got away from the member of the Faculty in charge of the boys and drank some liquor in a saloon.

Upon their return to the school they were immediately put under arrest and served their punishment in the guard house. In addition to this Willie and John were reduced to the ranks. Willie Deere, together with another one of the four, agreed to go with me to Philadelphia and locate the saloon where the liquor was obtained.

In accordance with this agreement I took these boys to Philadelphia. Willie and the other boy pointed out the saloon, identified the saloon keeper and we caused his arrest. The boys also appeared before the Grand Jury and I think the bartender will be indicted. The fact that the boys have gotten into this trouble together with their reduction to the ranks is their reason for running away.

John is of age but Willie is under age. I feel that everything possible should be done to return these two boys to the school. John Davis has a great deal of money. His education has only reached about the fourth grade and he will probably become the victim of sharks. Willie Deere also should receive more education. From the standpoint of the school both boys should be brought back. They have a large amount of Indian blood and are clearly the type of Indian who should be educated at Government expense.

We have whipped out the sale of liquor to our boys in and around Carlisle. Our only trouble now is in Philadelphia, and my idea was, by making an example of this one liquor case, to make it impossible for our boys, particularly when they are in uniform as in this case, to obtain liquor, and to successfully prosecute the case I must have these two boys as witnesses.

Anything that you can do to assist me in bringing about the return of these two boys I am sure will be beneficial not only to the school but to the boys themselves.

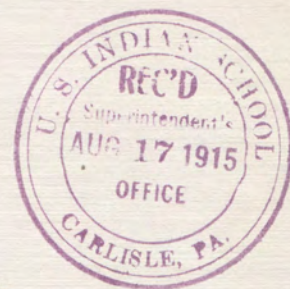
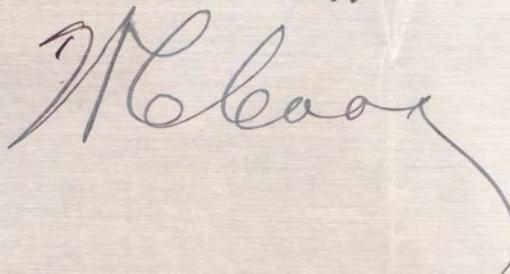
