SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a non-reservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

NOTE.—Age limits, fourteen to twenty years. Preferably fourteen to eighteen. Students must be at least one-fourth Indian, preferably full Indian. Special cases beyond the age limit will be given consideration. An industrial course only can be taken and the term reduced to three years, in exceptional cases.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations, or Indian schools, to nonreservation schools.

INFORMATION REQUIRED UNDER DECLARATION OF POLICY

Elimination of Ineligible Pupils from the Government Indian Schools.—In many of our boarding schools Indian children are being educated at Government expense whose parents are amply able to pay for their education and have public school facilities at or near their homes. Such children shall not hereafter be enrolled in Government Indian schools supported by gratuity appropriations, except on payment of actual per capita cost and transportation.





My dear Mr. Lonergan:

I am in receipt of your letter of April 17, 1918, regarding Victor Naranjo, now a student of this school. I have noted its contents and agree with you that Victor should be returned to Santa Clara and compelled to marry Eliza Cajete, and I will do everything possible to assist you.

In spite of circumstances, I doubt if I would have the authority to spend Government funds for Victor's transportation home, particularly as, in view of his age, we made him pay his transportation here.

Victor has no personal funds with me. Can you arrange for the payment of Victor's transportation? If you cannot to that, I might send him on the outing until he could raise enough money to go home.

I have not discussed the matter with him yet, as I feel that it would be advisable for us to plan out the details of his return before I go after him, otherwise he might endeavor to light out and avoid his responsibilities. I will be glad to have your further suggestions.

Dear Sir:

Some time in April 1915, Victor Naranjo who is now a student at your school, accompanied by his uncle who is his guardian, his parents being dead, called at the home of Pedro Cajete on the Santa Clara reservation and asked for the hand of Pedro Cajete's daughter Eliza in marriage. Cajete gave his consent and they were to be married at the annual fiesta that year which takes place August 12th.

The girl's father, Pedro Cajete, works at Colorado Springs and he left in April and returned the latter part of September. When he returned he was surprised to find that his daughter had not married. In the meantime, Victor had left Santa Clara and later, in December of that year, Eliza gave birth to a child. Victor has not returned to Santa Clara since and, as he seduced this girl on promise of marriage witnessed by his uncle, I feel it my duty to compel him to return and marry her.

Will you please give me any assistance you can in


