SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a non-reservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

NOTE.—Age limits, fourteen to twenty years. Preferably fourteen to eighteen. Students must be at least one-fourth Indian, preferably full Indian. Special cases beyond the age limit will be given consideration. An industrial course only can be taken and the term reduced to three years, in exceptional cases.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations, or Indian schools, to nonreservation schools.

Dear Mr. Lipps:

Reference is made to my letter to you of the 8th instant, regarding the taking into our family of one of your students, namely, Charlotte Cadotte, who is a first cousin of my wife.

Since writing you my first letter, I have been unofficially informed by a party who claims to know Charlotte very well, having attended your school during the years, 1915 and 1916, that Miss Cadotte is afflicted with scrofula or tuberculosis of the glands.

Acting in the best interests of myself and family, I will ask that you advise me the condition of Miss Cadotte's health, the physical condition as to her body. I would suggest that a thorough physical examination be made upon her by some competent physician, and have said physician report his findings to me in the nature of a physician's certificate. If it is true that Miss Cadotte's condition is such as has been told to me, then I will have to revoke my offer to

accept Miss Cadott into our family, as I, or no one else, for that matter, can afford to risk such a danger to his family, especially where small children are had, by taking into his family, one who is thus afflicted. I am sorry to have to feel that Miss Cadotte is in such bad shape, as when I knew her several years ago at Odanah, she looked the picture of health and one would never have thought that she would become afflicted with tuberculosis. Of course, what I have told you is merely hearsay, and I am hoping that such is not the case, although chances would appear to be against such. Something ought to be done for her, as by sending her West to some Sanatorium operated for the benefit of restricted Indians. If there is the least sign of tuberculosis discovered in her examination, I must refuse to take her into our family, as I was under the presumption, when I made my offer to accept her, that she was in good health and free of the terrible disease, tuberculosis.

Dear Mr. Francis:

Enclosed please find letter addressed to me by Henry E. Roberts, dated at Skedee, Okla., Feb. 25th, in relation to Charlotte Cadotte, a pupil in your school, being permitted to withdraw from Carlisle and make her home with the Roberts family on his stock farm in Oklahoma. Mr. Roberts' letter goes quite fully into the facts.

You will recall that this matter of Charlotte's being released from school has been brought up on two or three different occasions, but as she had not heretofore been able to determine just where she wanted to live, nor satisfy your Office and mine as to her being able to find a suitable home, I have heretofore rather discouraged her withdrawal from your school.

If she has served her four-year enrollment term and is ready for dismissal, and this action meets with your approval, I have no objections to her going to Oklahoma to live with the Roberts family.

Mr. Roberts used to be employed as assistant clerk at Odanah, and was formerly a Carlisle student, as was also his wife. From what I can learn of him, he is a very reliable, progressive young man, and it is very probable that Charlotte could find a good home with them.

If you and Charlotte conclude that it is best for her to act upon Mr. Roberts' request, kindly advise him direct and inform this Office at the same time of your action in the matter.

Dear Mr. Everest:

I wish to write you, on behalf of my wife, in regard to a cousin of hers, who at present is enrolled as a student in the Carlisle Indian school. The person I have reference to is one Charlotte Cadotte.

You, no doubt, are aware of the fact that my wife and family are now located out on my allotment, and have been for the last eight months. I am now engaged in the business of farming and stock-raising, and am pleased to say that so far everything has turned out all right. I have a nice farm of 160 acres and with proper management I ought to make a pretty good thing out of it.

Coming on the farm has increased the duties of my wife considerably and we now find that it will be necessary for us to get some young lady to help take care of our three little children, so as to give my wife more time to look after her household duties, such as cooking the meals, cleaning house, as well as to look after her chickens and spring gardening. My wife is not strong enough to take upon herself the care of the children and at the same time look after her other work. While we lived in the city I was able to help my wife in this respect, but my duties have also been increased since coming on the farm, as I am compelled to be away from the house a great deal of the time looking after our stock and getting the ground in shape for planting, single handed, as hire hands are almost out of the question, so much so, that I am now unable to help my wife very much.

My wife has always expressed her desire, that in case we were compelled to get someone to come and live with us for the purpose of relieving her of some of her duties, that we get her cousin, Charlotte Cadotte, as she is practically without a home, and Odanah is no place for a girl like her after leaving school. The environments in and around Odanah are not the kind for innocent young girls like Charlotte, as I have lived there long enough to know. You probably have found that out yourself by this time. Here with us she would be a safe distance from any town and right in the heart of a good respectable white settlement. We live fourteen miles from other Indians, and there is a district school just a mile away from our home. In fact, I don't believe that Charlotte could find a better home than we can give her, where she ^{will} be considered as one of the family, which makes a lot of difference. You can assure yourself, Mr. Everest, that Charlotte, if allowed to come down here, will be compelled to conduct herself the same as she would in a government school.. What we wish to do is to give her a home

My wife has recently addressed a letter to Charlotte at Carlisle, to ascertain from her whether she would like to come and live with us. We received an answer from her today, and she states she would be more than pleased to come.

Now, Mr. Everest, you are her guardian, in a way, and we would like for you to consider this matter and let us know what you think about it. You know it is the policy of the government to place Indian children in rural communities and in schools along with the whites, where it is possible, in order to get the Indian more used to the ways of the whites. Charlotte could go to public school here, and would be a help in taking

my children to school and back home. My little girl will be ready to start school by next fall. I am satisfied that Charlotte will like it here. My wife will be a constant companion for her.

Charlotte states that she has been at Carlisle four years. I do not know whether she has served out her term or not, but if you feel that you would like to give us an opportunity to try her out, I would suggest that you take the matter up with Superintendent Francis at Carlisle in regard to letting her come as soon as arrangements can be made.

In regard to the transportation, I will say, that it formerly was the custom to allow Indian pupils who had served out their terms, to allow them government transportation home. If she should be entitled to a government transportation home, I would suggest that you arrange with Mr. Francis to apply such transportation on her trip here. In case a sufficient amount is lacking to complete her car fare here, I will agree to reimburse Mr. Francis for the deficient amount, and perhaps Charlotte can reimburse me later, if she has any funds in the hands of the Government.

My wife's mother is Charlotte's nearest Aunt, and she has asked us time and again to take Charlotte into our home. I think Charlotte deserves a good home and she ought to be permitted to come and live with us as soon as possible.

Please explain the matter fully to Mr. Francis, as he does not know neither my wife, nor myself. It might be well for you to send this, my letter, along with yours to Mr. Francis, for his reference. The destination on the ticket, in case Charlotte is permitted to come, should call for Skedee, Oklahoma, where I can meet her.


I shall be pleased to have a letter from you shortly, telling me of your stand in the matter, and I know you will give it your personal consideration.

You probably recall about a year ago, we made an attempt to get Charlotte with us in Muskogee, but as we were able to get sufficient help for my wife, we dropped the matter for the present. At that time, if I remember rightly, Mr. Francis was willing that Charlotte should come and live with us. Now that we are out on the farm, we could use her to good advantage.

Dear Mr. Lipps:

I wish to make inquiry regarding one of your student members, namely, Charlotte Cadotte, a Chippewa Indian girl of Odanah, Wisconsin.

My wife, Rosie Denomie Roberts, is a first cousin of Charlotte, and yesterday my wife received a letter from her mother at Odanah, Wisconsin, in which she stated that if we cared to, we could take Charlotte into our home and bring her up. Charlotte, you understand, is without her parents, both her father and mother being deceased, leaving her and one brother, I believe, alone in this world and her aunt, who is my wife's mother, has more or less taken care of Charlotte since her mother's death. However, in her letter yesterday, Mrs. Denomie stated that it would hardly be possible for her to take further care of Charlotte, on account of her having so many children of her own to take care of, and requested that we take her into our family and rear her.

My wife and I talked this matter over and finally decided that we would take her, provided she cared to come. So I wish you would take this matter up with Charlotte at your earliest convenience and ascertain from her whether or not she would be willing to come and live with us, and be as one of the family. So far as her educational advantages and home environments as between Odanah and Muskogee are concerned, I will say that I have lived at both places and Muskogee offers far more advantages in these respects than that of Odanah, and in fact, taking everything into consideration, she will be much better off with us here in Muskogee than she ever will be anywhere else. Of course, it is optional with her whether she wants to come or not and she can do as she pleases as to that, but my advice to her would be to come.

I am not informed as to when her term of service will expire and would thank you to so advise so that if she decides to come to Muskogee I will know when to make arrangements for her home-coming. Also advise whether it will be necessary for her to pay her own transportation in case she should come to Muskogee at the expiration of her term, or whether she will be entitled to her Government transportation home. Any additional information that



My dear Mr. Dady:

Upon receipt of your letter of January the 26th, relative to the very unfortunate home conditions to which Charlotte Cadotte would have to go if sent away from this school, I sent the same to our Matron, Mrs. Ewing. This afternoon she submitted me the following:

"Referring to letter written by Supt. of Bayfield, Wis., Jan. 26th, '15, regarding case in question of Charlotte Cadotte, I think with the Supt. that it is really too bad to send her back to the reservation to such surroundings as he refers to, but with our girls here who need all the uplift we are able to give them I feel that a girl who has such filthy habits as she has shown and utterly ignores all advice, not only from the best girls here, one of whom I have put in charge of her and allowed her to room with the best girls, but she heeds no advice I give her unless there is some place of amusement she wants to attend.

She ~~xxx~~ also writes and receives questionable notes from boys and is disobedient in all the best things put before her.

I feel that the only salvation for her is to place her in a school for girls under the care of one of the good Sisters.

It has been unfair to the girls with whom she rooms and I feel that they should be relieved of her presence in the room.

I exceedingly regret to admit that I am unable to do her the good that should be done for a girl who has no home."

It cannot be necessary to add that Charlotte is almost a hopeless case and that I agree with Mrs. Ewing that the other girls here should be relieved of the presence of a girl like Charlotte, who cannot be anything but a contaminating and demoralizing influence on all those who have to associate with her. I do not agree with you that "if there is any place where these habits can be corrected and treated it is at one of our schools" because Carlisle and all the other schools are not supposed to be reform schools and we should not be expected to care for girls who have never been cared for or who have never responded to the right influences with which people interested in them have tried to surround them.

I want to do the very best I can for Charlotte, but Carlisle is not the place for her and she must be taken away.

Please find out as soon as possible and let me know whether those interested in her at her home would consent to have her sent to the House of Good Shepherd at Reading, Pennsylvania, if the Sisters there will undertake to take care of her if all the facts in the case are made known. Are there any funds available that could be used for her transportation or for her care while at such an institution?

Dear Sir:

I am very sorry to hear of the unfortunate habits of Charlotte Cadotte. I feel, however, in this particular case at least, if there is any place where these habits can be corrected and treated it is at one of our schools. The girl has no home. Before she left for Carlisle she lived with her brother Charles Cadotte in Bayfield, but he is unable to take care of her, for he has very little work through the winter, wages are extremely low, and he has a family of six children to take care of. His wife just passed through confinement, and I would not care to burden her with the care of this girl if she can be cared for in one of our schools. The wages of woodsmen this winter are only \$13.00 to \$16.00 a month and board, whereas two years ago they were from \$35.00 to \$40.00 a month and board for the same class of work. You will understand that this wage is hardly sufficient to keep even the smallest family on, let alone another young girl the age of Charlotte. Charlotte is really a member of the Bad River Reservation, although she has been living in this district for a number of years because her relatives have been willing to take care of her. I know that her brother Charles could not save sufficient money to pay her car fare home except as the result of denying his family necessities for several months to come, and this I feel is too much for me to ask them to do, particularly in view of the fact that we are having a very severe winter with very little work for men. Her sister-in-law's sister who lives in St. Paul, Minn., may be able to help her, and I have sent word through her sister-in-law to see if her sister would care for her.


I regret that it is not possible for her friends and relatives to help her, for I wish to relieve you of one you consider undesirable, but I hope she can stay for another reason, as my policeman put it very tersely yesterday "if she is sent home it means another girl gone wrong" as she is approaching the age of puberty and having no one to protect her her chances are none



Referring to your letter of February 8 in reference to Charlotte Cadotte Immediately on receipt of the letter I sent word to the people who had been caring for Charlotte when she left for Carlisle and asked them to communicate with any other persons whom they thought would be interested in order to find out what should be done with Charlotte. The only one who responded to the call was Charles Cadotte who did not seem to have any definite opinion as to what should be done with her, excepting that he did know that he had no money to pay for her expenses or give her for her care. He has a family of young children to care for himself, and he has not been working steady through the winter, and as the wages have been very low, I know that he speaks the truth. I wish to advise you that I have every reason to believe that Charlotte will secure funds from the distribution which is expected to be made at Ashland in the near future. Her name appears on the so called "Wooster Roll" which Dr. Wooster has just completed at the Bad River Reservation, but as to when the funds will be available, no one knows, nor will we

know until action is taken on the same by the Honorable Commissioner. As soon as we know if there are funds to her credit I will write you, and we can decide then what to do for the girl.

I am not very well acquainted with yourself or your family surroundings, but what meager information I have at hand indicates that either one or both of your parents are dead and that you have resided nearly all your life at Bayfield, or with the Red Cliff Band of Chippewas. Because of this fact, I am not in the best position to know whether it would be advisable for you to come home or not. I am, therefore, leaving the matter largely up to Superintendent Lipps for his decision whether it would be best for you to come home for the summer vacation. It may be that Superintendent Dady at Bayfield is better acquainted with your family relations and home conditions than I am, and in this event I would suggest referring the matter to him in case Superintendent Lipps should desire further information in deciding upon your

request.

For information of yourself, and Mr. Lipps as well, I would further add that you were placed on the rolls of the Bad River Band of Chippewas, under this jurisdiction, last fall, as a newly recognized member, and I have a deposit to your credit, at this time, of something like \$900.00 in money.




The two letters enclosed, one from Charlotte J. Cadotte, a pupil in your School, and the other written to Mrs. Cadotte by her cousin, Mrs. Rosie Roberts, of Muskogee, Okla., both refer to the question of Charlotte's withdrawal from the Carlisle School.

You will recall that some correspondence has passed between us heretofore in the matter of Charlotte's coming back to the local Reservation to live. This was discouraged by me because she has no home of her own and that the party with whom she expected to live at Odanah had no other motive in view except to have Charlotte a little closer to her bank account.

Charlotte's brother, Alec, has enlisted in the National Guard, and is apt to be called to training camp at Fort Douglas early next week. So there is no place on the local Reservation that Charlotte could call home.

However, her cousin in Oklahoma has conceived the idea of having Charlotte go down and live with her. Mrs. Roberts is a member of the local tribe, married to a Pawnee Indian, who has heretofore been employed in the Union Agency. Mr. Roberts is a very estimable man, and was at one time employed on this Reservation. I do not know as to the advisability of having Charlotte withdraw from school altogether and go down to Oklahoma to live. The matter of her doing so and the further question of her receiving \$50 of her bank deposit in my hands is referred to you for recommendation. Before taking any action upon either of her requests, I will await your advice.

The matter of her need for \$75.00 at the present time and also the question of it being advisable for her to come home during the summer vacation is referred to you for recommendation. Unless she does come home, I cannot see at this time the necessity for her to receive as large a sum as \$75.00, inasmuch as we have sent her money in amounts of about \$25.00 quite regularly.

As noted in former correspondence in relation to her visit home, Charlotte has no parents here and her brother has gone to the Army; she would therefore have to board with relatives if she came. My experience has been that girls who come back during the summer months for a short visit, especially to the local reservation, are confronted with temptations and environments that are not of the best. It might be advisable to interview her and ascertain as to where she expects to spend her vacation in case she comes home, and I will therefore await your recommendation as to both questions raised in her letter.


Dear Madam:




