Sir:

I am in receipt of a letter dated July 20, 1917, from Mr. Levi Levering of the Omaha Agency, Macy, Nebraska, with regard to the enrollment of Margaret Levering, his daughter, at Carlisle. Mr. Levering now has two children, Lincoln and Edna, enrolled at Carlisle. He also has another daughter Margaret Levering who has been at Genoa Indian School for three years and whose term has just expired. He desires that she be permitted to come to Carlisle.

It is doubtful if Margaret Levering has completed her course at Genoa and under the regulations the superintendent may claim that she should be forced to completed her course at that school.

It seems to me a very proper thing that the three Levering children should be together and in a similar situation I would feel myself justified in waiving the claim to one member of the family so that it might be enrolled at the school where two other members were enrolled.

Mr. Levering advises me that he has written the Office about the matter. I will be very glad to have Margaret enrolled here with her brother and sister and recommend that permission be given in view of all the circumstances.

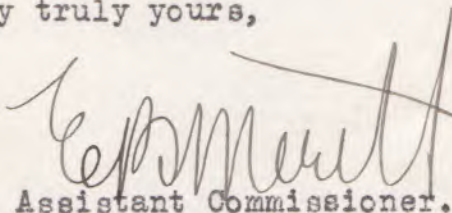

My dear Mr. Levering:

I am in receipt of your letter of May 21, 1918 in regard to the present whereabouts of your son, Lincoln Levering, a deserter from this school.

In response you are advised that I have not been able to get any information as to the location of your son. I assure you that as soon as I find out where he is, I will promptly advise you, and if he is located within a reasonable distance of the school, I will see that he is returned. I think upon consideration, in view of your experience as a school man, you will appreciate the very great problem to hold a boy here against his will, in these times of war, without resorting to drastic measures, which personally I would not care to use in the management of a school, and I am quite sure you would not want exercised towards a child of yours.

We are located right in the midst of the manufacturing area of the United States, where war conditions have made a tremendous demand for labor and extremely high wages, and have made it possible for almost any type of man or boy to get a job. At the Hog Island Shipyards common laborers are paid thirty cents an hour for an eight hour shift. Riveters, chippers, and that type of skilled labor, who can be trained in a few weeks receive fifty, sixty and seventy cents an hour. I am explaining this to you so that you will understand that there is every opportunity for a discontented boy to leave the

school and get into one of these manufacturing centers, and the only way we can locate him is either when he communicates with the school, or to stumble on him. To search for a boy under those conditions is like hunting for a needle in a haystack.

Early in April we received information that Lincoln was in Philadelphia, and I promptly sent the Outing Agent there to get him, but was unable to locate him.

Lincoln is a lad seventeen years old, who should have some general ideas of his own best interests. The Government has offered him training and education which he has seen fit to throw away. He ran away from you last fall when you arranged to put him in this school. He failed in his studies here and then ran away.

In view of these circumstances it would seem therefore that, while I am responsible to you for your son while he is in my charge, when he secretly leaves the school and conceals himself that he by his own action relieves the United States and me of a great deal of responsibility, and it seems unfair to assume lack of interest or negligence on my part in following up runaways because I have made it a practice to follow up and return runaways to the school.

Dear Sir:

You wrote me some time ago that my boy, Lincoln Levering, had run away from school, that you didn't know where he went and that you could not locate him.

Do you know now where he is? It is funny that you have kept silent all this time, never pay no attention to anybody what happens. You should continue to inform me about the disappearance of this boy who was a member of your school and I am sure you should know where each boy or girl is located. That is your business. I haven't heard anything of my boy all this time and I just wondered where he is. If you can furnish me further information in reference to this boy I will greatly appreciate it as I want to know something about him. It is my own interest in my family affair.

I think your school authority ought to exercise more strict ruling than it has been in the past, then there would be less run aways from your school.

I want to tell you that I was there as student of your school for nine good years. During those years we never allowed a student to get away, not even as far as Harrisburg and if he did he was a good one because we, as a body of students, helped the superintendent to keep good order and conduct in the school.

My dear Sir:

I have noted the information contained in your favor of recent date, and in reply thereto must state that I would prefer not to enroll the ten year old girl you desire to send to Carlisle with your two older children. A girl who is but ten years of age cannot be given the careful attention she should be given because, at Carlisle, the time is necessarily very limited that can be devoted to each girl. It is also a question in my mind whether a girl of that age should be allowed to associate constantly with older girls, some of whom are not always careful about their words and actions.

If the girl is received here at all you would be required to provide transportation for her. That provision has been in force for several years and only because of the enrollment of the older children can the girl be received at all.

After you have given this matter your further consideration please refer it to Superintendent Young and then let me hear what you desire to have done. The blanks I enclose may

Mr. John Levering Visits Us.

Mr. John Levering, class 1892, has been here on a short visit. He noted the many changes and improvements that have been brought about by the passing years, and spoke tenderly of the associations recalled by his presence here. He gave an excellent talk to the faculty and students in the auditorium Monday morning and among other things mentioned the Y. M. C. A. and the Standard Literary Society, of which organizations he was a charter member. He said he well understood the discouragements, and the many temptations which beset the student during school days, but with a well-defined purpose in view, and with the determination to make of themselves men and women, there was no reason why the Carlisle students, with the many advantages offered them, should not go out into the world and achieve success worthy of the training which they received while here. "Stick, and success is assured," were his closing words.

INDIAN DELEGATE TO GENERAL ASSEMBLY

Omaha Presbytery Honors Full Blooded Red Man.

Omaha, Neb., May 29. — When the Omaha Presbytery, in session at Florence, honored Levi Levering by choosing him a commissioner or representative of that body to the General Assembly, the highest body in the Presbyterian Church, few outside the Presbytery knew that Mr. Levering was a pure-blood Omaha Indian.

Mr. Levering was born on the Omaha reservation nearly 50 years ago. At 7 years of age he attended the Government school at the agency. He then attended the Presbyterian mission school, conducted by Rev. William Hamilton, four miles north of the agency on the river, where he studied three years. He then went to the Indian school at Carlisle, Pa., where he remained nine years.

On returning West he attended Bellevue College for three years. While at Bellevue he took special work in English. He was a member of the college quartet and traveled through the West on a concert tour during the summer. As a member of the Young Men's Christian Association at Bellevue he made an address at Fremont, Neb., the direct results of which were that several young men made confession of their faith in Christ.

From Bellevue Mr. Levering went to Fort Peck, Mont., to teach in a Government school, but was transferred to an Indian school at Fort Hall, Idaho, where he remained nine years. While at Fort Hall he married Miss Vena Bartlett of the Bannock tribe, and returned to the Omaha reservation, where he has been conducting a store for five years.

Mr. Levering has a beautiful home near his place of business, which is furnished with great taste and is a model house in every particular.

Last December Mrs. Levering died of typhoid fever, leaving five children under 12 years of age.

Mr. Levering has been superintendent

of the Blackbird Hills (Indian) Church Sunday school three years and an elder for two years. He represented the church at the recent Omaha Presbytery and his election as commissioner to the General Assembly followed.

I am getting along very nicely at this school, trying to run it and making improvements every day; I'll do my best to make it a good record of myself, and use my best powers that is within me.

Of the 5000 employees now handling the Indians' business, 291 are Carlisle graduates.

"Those who have investigated," declares Superintendent Friedman, "are absolutely convinced that the Indian problem will never be solved until more red men get into the Indian service. It used to be held that the Indian was not the equal of the white man, and despite the fact that he passed the civil service was placed in lower positions than the white man and few trusted places were given to him.

"But there has been a change. Today some of the most efficient men in the Indian service come from Carlisle. Of the 291 in the service from this place their positions range from superintendents of schools, forest guards and interpreters, to stenographers, chiefs of police, supervisors and teachers.

Among them was Levi Levering, a merchant on the Omaha reservation and a Carlisle graduate, who represented his district as delegate to the General Assembly of the Presbyterian Church last year. He declared while here that the educated Indian boys and girls do not go back when they leave school, but go forward and make the most out of life.

With this same group was Albert Blackbird, who, Levering said, raised 5,000 bushels of corn last year on his Nebraska farm and is an elder in the Presbyterian Church. Blackbird received his agricultural and academic training at Carlisle.
