Through General Pratt I entered the Indian Service in 1913, the year after my graduation. My first appointment was at Greenwood, S. D. as assistant motorist at a salary of \$300 a year. There, I stayed nearly three years when I resigned my position and came home for a few months rest.

Following this I had another appointment for the same position at Lame Deer, Montana at \$420 a year. I accepted and remained a little over a year as the climate did not very well agree with me, I asked for a transfer and instead was granted a sick leave for a month. In the meantime I was offered a position in Wisconsin at a salary less than the position offered me in Montana and was given a preference to the two places. I decided to accept the place in Wisconsin, for, it seems the high altitude did not agree with me. After

staying there nearly a year I was transferred back to my first place, Greenwood, S.D. at a salary of \$300 a year, and which was a promotion. But I found the work there very hard and I soon was runed down in health again, and this was one of the chief reasons of my resignation so I resigned in Dec. 1908 and have been home since. While I am home I intend occupying my time in a way that will be more beneficial to my health.

I think I can soon regain my health as my home is on a large farm.

In all my experiences in different places I have enjoyed my work and would have remained had it not been for the handicap of ill health.
