SUGGESTIONS FOR SUPPLYING THE INFORMATION REQUESTED ON THIS BLANK

1. The report of nonreservation school Superintendent should be made at the time or a little before the pupil leaves school, whether at the end of the school year or during the school year, provided the pupil is 18 years of age or over, or younger, if for any special reason the pupil is quitting school permanently. As soon as this report is received, or at least very soon after the pupil returns home, the Supervisor of Indian Employment will correspond with the returned student for the purpose of getting more in personal touch with him and finding out something about his wishes, etc. His answer will be attached to and filed as part of this report.

2. Health, height, and weight of returned students are sometimes very important in placing them properly; height and weight could be approximated very satisfactorily, though from the pupil records now in use all information called for in part 1 of this blank can readily be obtained and be definite.

3. The State, agency, and tribe are important, and where the pupil is not attached to any agency this fact should be stated and the Superintendent should give all available information as to the home and local conditions surrounding the pupil.

4. Where the outgoing pupil has passed the civil-service examination for any position, this fact should always be noted, giving position for which examination was taken.

5. It should be remembered that the Supervisor of Indian Employment can but seldom have a personal acquaintance with the outgoing student, and that he must depend on the information furnished in this report for his basis of action in behalf of the pupil.

6. The degree of Indian blood should always be given, as this fact largely determines how much effort will be made on behalf of any particular returned student; qualifications being equal, or nearly so, the preference will be given to those having the greatest degree of Indian blood.

7. This report should be forwarded promptly to the Supervisor of Indian Employment, Denver, Colo.

8. Reports on students from reservation schools should be made only as to those who leave the schools at 18 years of age, or older, and who will probably not go away to school.

9. If part 1 of this report is made out by the principal of a reservation school, the reservation Superintendent should supply information called for in part 2 if the principal is not informed as to home surroundings and local conditions. Such information is essential to a proper understanding of the difficulties and needs of the pupil.

10. When part 1 is made out by a nonreservation Superintendent, this blank will be sent by the Supervisor of Indian Employment to the Superintendent of the reservation where the outgoing student belongs. He should fill out part 2 and return the blank as promptly as possible, for practically nothing can be done until the information called for in part 2 is supplied.

Information under the heading "Employed since return as follows," will be valuable only in cases where the pupil has been home for some time.

INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other non-reservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.

My dear Peter:

I have just received a letter from Mr. St. Germaine in which he stated that you have not yet found work and are in need of \$10.00 to pay expenses for a few days until you find employment. He suggests that this amount be loaned from the athletic fund.

In this connection I have to advise you that since the athletic fund has to be accounted for by me as other funds, I cannot draw on this account except to pay bills incurred for the general benefit of the school or association. The Office has recently advised me that this fund cannot be used for the benefit of any individual pupil of the school. This being true and still feeling disposed to give you a helping hand in a time of need, I am sending you herewith my personal check for the sum of \$10.00. This, together with the \$5.00 I gave you when you left here, makes \$15.00 which you owe to me, and which you may return to me as soon as you have earned the money. I am always very glad to help a fellow who is trying to help himself and I have faith in your honesty and good intentions, and while I could not make a general

practice of loaning money to pupils, as I do not have it to loan, I am making an exception in your case for the reason that I have faith in you.

Please let me hear from you as soon as you are located. If you fail to secure work soon, I would advise you to return to the school and we will then see what we can do to find something for you. It is usually a better plan to have a job in sight before leaving the school, and had I known your intentions in time I should have made every effort to get a position for you before you went away.

My dear Mr. Lipps:

Peter Jordan was in to see me to-day at our office and says that he is without funds. I am accordingly helping him out with a few dollars until he finds work. He wants me to ask you to send him \$10.00 care of this office and charge *to the Athletic Fund, he to return this loan from his salary after he gets work.*

For your information I shall say that Mr. Findlay, who is at the head of the Contract Department at Wanamaker's, assured me last Saturday that he was doing all he could to obtain work for Peter. I personally, and at Mr. Findlay's suggestion, saw a Mr. Wm. Pack at the Bingham House last Saturday with reference to Peter Jordan's case. This man wants a young man to work for a certain Acetylene Company whose headquarters are at York, Pa., of which he is a representative. After giving me an idea of the nature of the work, I recommended that he give Peter Jordan a trial.

Mr. Pack stated that this kind of work does not need expert salesmanship, but that any energetic young man and willing worker can learn to handle their line. They start a young man at a salary of \$100.00 and allow him \$25.00 for expenses. I made an appointment for Peter Jordan to meet Mr. Pack at the Bingham Hotel next Saturday noon at which conference Mr. Findlay will also be present. In the event that Peter does not obtain work from Mr. Pack I think I am safe in saying that Mr. Findlay will have something for him at that time, at any rate he needs \$10.00 at this time to see him through.

My dear Peter:

Your letter of September 29th, enclosing Post Office Money Order for \$15.00, the amount I loaned you last spring, has been received.

I note what you say regarding the telegram from the Associated Press of Carlisle, stating that you are twenty-eight years old, played four years on the Carlisle football team, etc. You evidently are under the impression that I had something to do with sending this telegram. I wish to assure you that I knew nothing whatever about it, and I would not be a party to anything of that kind. Just as I told you last spring, I think it an excellent thing for you to attend Keewatin Academy, and if you can pay your expenses by assisting in the athletics in the school, all very well and good.

I sent a telegram to Joe Guyon, stating that I was expecting him here, and I also wrote a letter yesterday to Gus Beaulieu, at White Earth, and explained to him the record Joe had made here and that the boys were anxious to have him return to Carlisle, but I stated that I did not want

to do anything against Joe's best interests, but thought it would be for his best interests to spend another term or at least another year at Carlisle. Mr. Warner thought, perhaps, you had influenced Joe to go to Keewatin with you, as he received word several days ago that Joe was in Chicago on his way to Carlisle. Joe also wrote me sometime ago that he would leave for Carlisle, stopping in Wisconsin enroute, and asking if I would reimburse him for his expenses on his arrival here, which I agreed to do. This is all I have heard from Joe since he left here last June.

I have no desire whatever to interfere with any plans that may be for the best interests of you and Joe, and as I said before I had no knowledge, whatever, of the telegram you refer to being sent, and I am in no way responsible for sending it.

I can see no objections, whatever, to Keewatin employing you to assist in athletics, and even though you are twenty-eight years of age, I know of no reason why a man twenty-eight years of age should not be at liberty to go to school, if he so desires. I believe if you will show this letter to the school authorities there, they will understand the situation and that you will experience no further annoyance or inconvenience by reason of the telegram to which you refer. I should state, however, that I did see a telegram yesterday from Keewatin referring to the Associated Press

telegram of which you speak. Mr. Warner had this telegram, and that was the first I knew of your enrollment at Keewatin Academy.

Don't you really think that in view of Joe's very satisfactory record at Carlisle and the great opportunity his standing in the athletic teams here gave him, that it would be for his best interests to return to Carlisle for at least another year? I would not for a moment stand in the way of Joe's best interests, but I really believe he is making a mistake in leaving Carlisle at this time. As I have known Joe since he was a small boy, I am naturally much interested in him than any other boy in the athletic teams here, but notwithstanding this I would not encourage him to return to Carlisle solely for athletics or even with that as his chief object. He has made a splendid record in his trade, and we are reorganizing all of our departments here and improving them, and I believe Joe would get better training here at his trade than he could probably get at any other school in the country, for at least another year or two.

We are also going to add two more years to our course of study which will make Carlisle equal to other preparatory schools, although our course of study will not conform exactly to that of other similar schools. Please see Joe and talk this matter over with him and ask him to write me fully his views regarding the matter. Whether he returns to Carlisle or not, I wish him every success and I

will hold nothing against him if he does not return, and for you Peter I wish you a very successful year, and I hope you will stick to business and make good. You had a good record here, and I know of no reason why you should not make a good one there. Please let me hear from you from time to time.

Dear Mr. Fryer:

Reference is had to your letter of October 19, transmitting the application of L. A. Myers for a coal mining lease covering Navajo tribal lands.

The law under which leases of the kind involved are issued requires that duplicate copies of the location notice must be filed with the Agency Superintendent within sixty days from date of location and that application for a lease must be made to the local Superintendent within one year from date of filing of the location notice. Your records do not show that the copies of the notice were filed in the Agency office. The applicant claims that he filed a copy of the notice at the Agency Office within a week or ten days after making the location on October 13, 1933. The Chairman of the Navajo Tribal Council states that Mr. Myers made application to the Council for a lease in the spring of 1933. The Agency records do not disclose the reasons for failure to take action on the matter until after the lands had been closed to location and lease. It is reported by the Senior Forest Ranger that the development work consists of about 318 feet of tunnel.

There is no evidence aside from the applicant's statement to show that he filed at the Agency Office copies of the location notice prior to March 25, 1936, the date on which the lands were closed to location and lease. In the circumstances it is suggested that the matter of opening the lands be presented to the Tribal Council for consideration at its next regular meeting. This Office would be willing to recommend the opening of the lands to location and lease if such action is agreeable to the Tribal Council.

If and when a lease in favor of Mr. Myers is submitted to the Department for consideration the map and the memorandum of the Senior Forest Ranger should be forwarded here. The map and the memorandum are returned herewith in accordance with your request.
