OMAHA INDIANS WIN LONG DRAWN OUT SUIT

Hiram Chase, Jr., Fails to Get
Award of Land Allotted
to Tribes.

Added Interest to Hearing Be-
cause Burial Ground of
Tribesmen.

The famous allotment suit of the Omaha Indian tribe, which has been before the courts for a numbers of years, was decided yesterday afternoon by Federal Judge Woodrough in a decision which upheld the contentions of the tribe and denied the petition of eighty-one heirs represented by Attorneys John L. Webster and Hiram Chase. The case involved 5,000 acres of land on the Omaha Indian reservation, some of which is valued at \$175 per acre.

The suit had its rise from action taken in 1893 to allot lands to the different Omaha Indians. The reservation contained sufficient land to make this allotment, with about 5,000 acres left over.

In 1909, Hiram Chase, jr., born after the settlement of 1893, picked out a quarter section of the 5,000-acre "left over," and made claim to it on the grounds that he had never received an allotment.

While the case was in court a committee of Indians, headed by Harry Lyon and Silas Wood, went to Washington and succeeded in getting through congress a bill to sell the 5,000 acres of Indian land and to divide the proceeds among the Indians who were born after the settlement in 1893 and who had not received an allotment.

Seventy-five other young Indians joined in the suit with Hiram Chase, jr., and before the decision of the court was made, five additional young Indians filed similar suits, making eighty-one Indians who asked allotments instead of cash. Because of the limited amount of land, if these eighty-one Indians had won the suit, there would have been nothing left for 560 Indian children who were born after the 1893 allotment, but who were not among those bringing the suit.

Judge Woodrough decided that the land should be sold and the proceeds divided among all those Indians who have no allotments. The value of the land is about \$300,000.

Part of the land which young Chase asked the court to confirm to him contained the ancient tribal burial ground of the Omaha tribe, and there was much uneasiness among the Indians as to what would be done if this cemetery passed into the hands of individuals instead of remaining the property of the tribe.

Yesterday evening Harry Lyon and Silas Wood, head men of the Omaha tribe, left for Washington to present a petition to congress asking that body to appropriate and pay to the tribe \$450,000 which the tribe recently won from the government in a law suit. The money was in settlement of a suit of many years standing for horses furnished by the Indians to soldiers, for a hospital which the government was to have built for the Indians but did not build, for property alleged to have been stolen by Indian agents and for several other claims. The suit was settled in favor of the Omahas but the money has not yet been appropriated by congress.

2.
