In reply I respectfully state that Wilson is provided with all the necessary articles of clothing, but if he has funds to his credit which may be expended for such a purpose and which are not more urgently required for any other purpose it is my opinion that he should be allowed the use of that amount. I recommend to that effect and if the money is sent to me for deposit in our school bank expenditure of the amount will supervised.

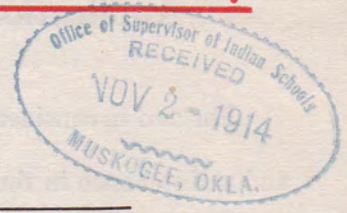

SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a non-reservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

NOTE.—Age limits, fourteen to twenty years. Preferably fourteen to eighteen. Students must be at least one-fourth Indian, preferably full Indian. Special cases beyond the age limit will be given consideration. An industrial course only can be taken and the term reduced to three years, in exceptional cases.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations, or Indian schools, to nonreservation schools.

My dear Mrs. Hendricks:

We have your letter of the eighth instant, making further reference to the condition of your son Wilson Wiley. After I had written you a few days ago, I sent a memorandum to our resident physician, asking him to let me have as soon as convenient the result of his observations concerning this boy. The physician sent me a preliminary report, stating that immediately after Wilson had been admitted to this school he (the physician) had noticed an abnormal mental condition in the boy. This would seem to be contrary to your statement that if Wilson is in any degree mentally deficient, such condition must have developed since he came to Carlisle. However, that is neither here nor there, and it is earnestly believed and hoped that the condition may be only a temporary one and due to causes which will respond to treatment upon the part of our physician.

Wilson is going about his studies and work at present, and to my way of thinking he seems to be considerably improved. I would not counsel his being withdrawn from the school until at least we may have a further statement from the physician. Of course, you understand that in a case like this it may take the physician several weeks or even months to come to a definite decision, since such cases are difficult to study and observe.

I think, therefore, that there is no immediate cause for worry. In fact, as I have already said there seems to be reason for thinking that his condition is only a temporary one and that it is already improved.

My dear Mrs. Hendricks:

We have your letter of December 25th, in regard to your son Wilson Wiley. I must confess that Wilson is one of the greatest problems I have ever encountered in my twenty-five years of experience as a school teacher and official. He seems to be all the time in a dream and he goes about with a vague expression, which would seem to indicate a deficient mentality. Whether or not this is a condition which developed after he reached Carlisle I am quite unable to say. In the academic department, his conduct has been reasonably satisfactory, but he does very little good in his studies. His marks are low and he does not seem to be able to grasp the subject matter.

His conduct in and around quarters has not been so satisfactory, and it has been necessary to make him the subject of more or less severe disciplinary measures on several occasions. We are perfectly willing to keep him on and do the best we can for him. It is possible that his case should be made the subject of special study upon the part of our school physician, and I am this day directing Dr. Rendtorff to make an observation of his case.



Sir:

Reference is made to your letter of April 28, 1917, in which you direct attention to that paragraph of the Declaration of Policy in the Administration of Indian Affairs which refers to Indian students who have completed the course of instruction in the Government schools, being declared competent.

In accordance with these directions I have the honor to report that Wilson Wyley, a $\frac{1}{2}$ blood Cherokee Indian 17 years of age, passed his examinations and on May 24, 1917 was graduated from this school in Gardening, in accordance with the special course of study.

Wilson is the son of Josie Gritts. His father is dead. Both parents were well educated. His home is at Ochelata, Oklahoma. He has 120 acres of land. Since coming to Carlisle he has worked most of the time in the greenhouse. He wishes to become a lawyer.

Principal Blair and Director of Mechanic Arts Bradley reports that Wilson is peculiar in many ways; he seems utterly irresponsible at times. He has little or no sense of proportion and is given to nursing real or imaginary grievances. He does well, only occasionally, in any line of work. This of course has made things uncomfortable for him at times. He has been afflicted with boils and other skin eruptions almost continually. He looks like a white boy.

He spends his money freely.

Wilson is in good health except for the skin trouble.

Superintendent Parker of the Five Civilized Tribes reports that Wilson has 10 acres of land. If there are any restrictions in this land it should be removed when he becomes of age.
