INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other non-reservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.

My dear Friend:

I have just received your letter of October the 2nd, and in compliance with your request I am arranging so that your brother Charles and your sister Nancy will be provided with transportation at Pinconning by the Agent of the Michigan Central Railroad there. I could not place transportation for your use because you are now more than twenty-one years of age and because you desire to enroll for but one year. It is hoped, however, that you have saved sufficient funds from the amount that was recently sent you to pay for your transportation and so that you can come on with Charles and Nancy.

As is suggested by you I am also placing transportation for Rachel Cabay's use with the Agent of the Michigan Central at Bay City. I am asking Rachel in a letter to get into touch with you and so that all of you can come on together.

Sir:

Reference is made to your letter of April 28, 1917, in which you direct attention to that paragraph of the Declaration of Policy in the Administration of Indian Affairs which refers to Indian students who have completed the course of instruction in the Government schools, being declared competent.

In accordance with these directions I have the honor to report that Flora Peters, a full blood Indian Chippewa Indian, 24 years of age, passed her examinations and on May 24, 1917 was graduated from this school in Home Economics, in accordance with the tentative course of study.

Flora is the daughter of Joseph W. and Julia Shaycaw Peters of Pinconning, Mich. Her father is a farmer and both parents were quite well educated. They live two miles from town. She has worked in all of the industrial departments since coming to Carlisle. She likes sewing the best and wishes to make sewing her life's work.

Principal Blair reports that Flora is considered a fine girl, but she has little aptitude for the academic branches. She is very good at housework; is conscientious and straightforward in disposition and a willing worker. For one year she held a position as matron in the Indian Service and then returned to Carlisle to graduate.

Matilda C. Ewing reports that Flora is willing to take the initiative, but her judgment is not always good. She tries to do well, whatever she undertakes, but is not strong physically. She will make a strong guiding superior.

Flora is in good health, and very careful of spending money.

Superintendent Cochran reports that Flora has no land or allotment as far as he knows under the jurisdiction of the government. He advises me that she comes of poor parents, and her home life is probably none of the best.

In view of the facts it would seem that Flora Peters is capable of managing her own affairs, and I would recommend the issuance to her of a certificate of competency.

INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other non-reservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.
